**One. Aim**

The Government of Mongolia announced 2023-2025 as the "Year of Visiting Mongolia" and issued a resolution, approving the name "WELCOME TO MONGOLIA-EVENT 2023" for the calendar along with 22 measures to be implemented to promote Mongolia abroad, stimulate the activities of the tourism industry, boost the economy and increase investment. The event "Healthcare Technology-International Expo 2023" is scheduled in this calendar, which will be organized in accordance with the 100<sup>th</sup> anniversary of modern Pharmaceutical Industry in Mongolia. The aim of "Healthcare Technology-International Expo 2023" is to promote new treatments, diagnostic advanced technologies, methods, services, foreign and domestic medicines and activities and products of manufacturers and suppliers, hospitals and healthcare organizations, and improve the knowledge of proper drug use, strengthen cooperation between government, the private sector and international organizations and attract investment.

- Governmental and non-governmental organizations;

1. Introduction of advanced technologies for newly launched treatments and diagnostics in the healthcare field

3. of domestic manufacturers and suppliers to consumers, establish close contacts between manufacturers, importers and consumers and strengthen their cooperation;
4. Promote the health products of foreign manufacturers and suppliers in the domestic market;
